- 1. RECEPTION: LOW SEASON- 01 September to 15 June** - Open Monday to Saturday from 10:00 AM to 12:00 PM and from 2:00 PM to 7:00 PM – (CLOSED ON SUNDAYS)- **HIGH SEASON- June 16 to August 31** - Open Monday to Sunday from 9:00 to 8:00 PM.
- 2. FORMALITIES:** Clients are required to present their identification documents at the reception upon arrival. For security reasons, all minors not accompanied by adults are not accepted in the campsite.
- 3. ARRIVALS:**
BARE PITCH - Arrivals are from 2:00 PM to 7:00 PM in low season and from 12:00 PM to 8:00 PM in high season.
MOBILE HOMES - Arrivals are from 2:00 PM to 7:00 PM in low season and from 2:00 PM to 8:00 PM in high season. All arrivals outside the hours indicated above will be accommodated as soon as the reception opens (parking outside the campsite is available while waiting for the opening time of the reception).
- 4. DEPARTURE:**
Mobile homes must be vacated by 10:00 AM. Please be advised that the final cleaning must be done by the client. For all departures before 6:30 AM, please do not forget to park your vehicle in the parking lot outside the campsite the night before your departure date.
Pitches must be vacated by 12:00 PM. Late check-outs or extensions must be notified to reception at least 24 hours before the scheduled departure date (subject to availability).
Late check-in or early checkout on your behalf will not result in any refund except in case of subscription to the cancellation guarantee.
- 5. INSTALLATION:** All camping equipment must be installed at the designated location in accordance with the instructions given by the camping's representative. Everyone is required to refrain from any action that may affect the cleanliness, hygiene and appearance of the campsite and its facilities, including sanitary facilities. The pitch must not be occupied by any other installation other than the caravan, motorhome, or tent, in accordance with the camping regulations.
- 6. TRAFFIC CIRCULATION AND PARKING:** Please note that the entrance gate of the Campsite is closed to vehicular traffic after 10:00 PM until 6:30 AM. It is forbidden to block and force the opening of the gate "ALARM SYSTEM AND VIDEO SURVEILLANCE". However, you can enter or leave the campsite at any time on foot or by bike using the CODE or BADGE that was given to you during your check-in at the reception. Circulation within the camping site is limited to 10km/h. **Parking is reserved for 1 vehicle per pitch or mobile home (for safety and evacuation reasons) unless agreed by the management with a surcharge of 3.90 € /day. Parking is not permitted on access roads and neighbouring plots, even if they are empty.**
- 7. PARKING OUTSIDE THE CAMPSITE:** If you arrive after 10:00 PM or if you wish to leave before 6:30 AM, you must park your vehicle in the car park outside the campsite. Guests are invited to take the usual precautions for the protection of their vehicle and their equipment, the campsite disclaims all liability in the event of damage, breakage, or theft.
- 8. SECURITY:** the campsite is under video surveillance; the management declines any responsibility in case of theft. The management is only responsible for objects left at the reception.
- 9. CHARGING OF ELECTRIC VEHICLES:** Charging of electric or hybrid vehicles on the premises is strictly prohibited for safety reasons due to insufficient electrical power. In case of non-compliance, the cost of any damage detected, and its repair will be charged to the client.
- 10. FIRE:** Only individual electric or gas barbecues are allowed on the site. For the respect of the environment and fire safety instructions, the charcoal barbecue is prohibited outside the collective areas set up for this purpose. It is strictly forbidden to throw cigarette butts on the ground, ashtrays are provided for this purpose.
- 11. NOISE / NUISANCE:** **"NO- NOISE"** is strictly implemented from 9:00 PM (no noisy musical instruments, moderate sound volume, no untimely shouting and slamming doors). In case of numerous complaints or violence, the expulsion will be immediate and without the possibility of refund.
- 12. BEHAVIOUR:** Drunkenness in the campsite may be sanctioned by permanent expulsion. Over consumption of alcohol, the consumption of narcotic drugs and illicit products is prohibited. Any disrespectful or violent person will be the subject of a complaint to the police and will be permanently expelled from the campsite. **PRIVATE PARTIES OR FESTIVE EVENTS ARE NOT TOLERATED IN THE CAMPSITE.**
- 13. GAMES:** No violent or annoying games can be organized in the facilities. Children should always be under the supervision of their parents. Parents are reminded that it is strictly forbidden for their minor child(ren) to play near the rivers. In the event of an accident, the campsite disclaims all liability.
- 14. ANIMAL (FOR SHORT STAY ONLY):** Camping Paris Beau Village may authorize the keeping of animals (max. 2), provided that the said animal does not cause any damage. They must be always kept on a leash. They must not disturb the tranquility and safety of residents and respect the basic rules of hygiene. Dogs considered dangerous (category 1 and 2) are prohibited on the Campsite. Up-to-date vaccination record is required. **IT IS FORBIDDEN TO FEED WILD OR STRAY ANIMALS WITHIN THE CAMPSITE.**
- 15. WI-FI:** Wi-Fi connection is available on almost the entire campground. FREE WIFI access is also available at the campsite's bar and reception. The WI-FI connection is reserved for personal use in compliance with current legislation. The client is responsible for the proper use of the service and undertakes to guarantee SAS le Beau Village against any action or recourse brought by a third party. SAS Le Beau Village declines all responsibility in the event of non-functioning or incompatibility with the customer's equipment.
- 16. OCCASIONAL VISITORS:** As a security measure, all visitors must declare themselves at the reception during opening hours before being allowed to enter the Campsite. The visitor is under the responsibility of the camper or tenant who receives him. **"Passing visitor (day)- supplement €4.00 /person. Night visitor-supplement € 8.00 /person »** Visitor's vehicles must remain outside our establishment.
- 17. INTERNAL RULES AND REGULATIONS:** The fact of staying on the campsite implies acceptance of the provisions of the internal regulations and the commitment to comply with them. The rules of procedure are posted at the reception and on the outdoor bulletin boards. Clients are required to respect and to comply with it.
